

## Terms and Conditions for use of the ABS Benchmarks

1.   - c. shall be liable for any loss of business or profits nor any direct, indirect or consequential loss or damage resulting from the use of the ABS Benchmarks or any inaccuracy, or irregularity of the published ABS Benchmarks.
